

RESOLUTION OF THE PRESIDENCY OF THE STATE AGENCY CONSEJO SUPERIOR DE INVESTIGACIONES CIENTÍFICAS M.P., BY WHICH AID IS GRANTED FOR THE TRAINING OF PREDOCTORAL RESEARCH PERSONNEL ASSOCIATED WITH THE CALL FOR EARLY PROCESSING FOR THE YEAR 2022 OF THE CONCESSION PROCEDURE FOR "PROYECTOS DE GENERACIÓN DE CONOCIMIENTO", WITHIN THE FRAMEWORK OF THE STATE PLAN FOR SCIENTIFIC, TECHNICAL AND INNOVATION RESEARCH 2021-2023, OF THE STATE RESEARCH AGENCY.

The Resolution of December 30, 2022 of the Presidency of the State Research Agency (hereinafter, AEI) approved the call for early processing for the year 2022 of the procedure for granting aid to "Proyectos de Generación de Conocimiento" and actions for the training of predoctoral research personnel associated with these projects, within the framework of the State Plan for Scientific, Technical and Innovation Research 2021-2023.

By Resolution of October 24, 2023 of the Presidency of the Agencia Estatal Consejo Superior de Investigaciones Científicas (hereinafter, CSIC) approved the call for the process of evaluation and selection of the beneficiaries of the grants for the training of predoctoral research personnel, as stipulated in Article 12 of the call for early processing for the year 2022 of the procedure for granting "Proyectos de Generación de Conocimiento" of the AEI.

By Resolution of January 11, 2024 of the Presidency of the CSIC, the grants for the training of pre-doctoral research personnel were awarded to the selected persons who, appearing in first position in the Proposal of Final Resolution of December 29, 2023 for each contract, had presented jointly with the responsible research personnel the agreement of incorporation in due time and form as established in article 9.1 of the call.

In accordance with the provisions of article 9 of the call, the Presidency of the Agencia Estatal Consejo Superior de Investigaciones Científicas M.P.

RESOLVES:

1. To award the grants for the training of pre-doctoral research personnel listed in Annex I of this resolution to the substitutes included in the Final Resolution Proposal of December 29, 2023, who have reached an incorporation agreement with the research personnel responsible for the corresponding project.
2. To reject the awarding of the grants for the training of pre-doctoral research personnel listed in Annex II of this resolution to the selected persons included in the Proposed Final Resolution of December 29, 2023 who have presented their resignation.
3. To reject the awarding of the grants for the training of predoctoral research personnel listed in Annex III of this resolution to the substitutes included in the Proposed Final Resolution of December 29, 2023 who have not reached the proposed incorporation agreement due to withdrawal.
4. To designate the persons listed in Annex IV of this resolution as alternates, who will be proposed, in strict order of priority, to reach the incorporation agreement in the event of resignation by the candidate who holds the corresponding contract, in accordance with the provisions of Article 9.5 of the call. The conditions of execution are those set forth in this resolution and in the call for proposals, with the possibility of issuing specific instructions if necessary.

5. List in Annex V the contracts that, due to the resignation of the incumbents, or due to the withdrawal of the agreement of incorporation proposed to the substitutes, remain vacant in the first phase. The selection process for these projects will continue in the second phase, in accordance with the provisions of Article 8.4 of the call. The conditions of execution are those set forth in this resolution and in the call for proposals, with the possibility of issuing specific instructions if necessary.
6. The conditions of execution are those set forth in this resolution and in the call for proposals, with the possibility of issuing specific instructions if necessary.
7. To order the publication of this resolution and its Annexes in the electronic headquarters of the CSIC, for the purposes provided for in Article 45 of Law 39/2015, of October 1 of the Common Administrative Procedure of Public Administrations.

A contentious-administrative appeal may be filed against this resolution, which puts an end to administrative proceedings, within two months from the day following its publication, before the Contentious-Administrative Chamber of the High Court of Justice of its Autonomous Community or the High Court of Justice of Madrid, at the appellant's choice, in accordance with the provisions of articles 10. 1.i) and 14.1 Second and 46 of Law 29/1998, of July 13, regulating the Contentious-Administrative Jurisdiction or, optionally and previously, an administrative appeal for reconsideration within one month before the same body that issued it, in accordance with articles 123 and 124 of Law 39/2015, of October 1, of the Common Administrative Procedure of Public Administrations.
